### Section 4: First Aid Measures

<b>Eyes:</b>	Immediately flush eyes with water for 1520 minutes, while holding eyelids open. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Seek medical attention at once.
<b>Skin or Clothing:</b>	Take off contaminated clothing. Rinse skin immediately with plenty of water for 1520 minutes. Call a poison control center or doctor for treatment advice.
